### **Geographical Jurisdiction**

This contract is binding only upon work in the following areas: The entire Counties of Broome, Cortland, Delaware, Tompkins, and Onondaga; Madison County [Townships of Sullivan, Lenox, Cazenovia, Fenner, Nelson, Deruyter and Georgetown]; Oswego County [All Townships except Redfield, Sandy Creek and Boylston]; Alleghany County [Townships of Almond, Burns and Alfred]; and Steuben County [Townships of Prattsburg, Pulteney, Canisteo, Howard, Fremont, Avoca, Wheeler, Wayland, Cohoctan, Dansville, Hornell, Hartsville, Greenwood, West Union, Troupsburg, and Jasper]. Chenango County [Townships of Afton, Bainbridge, Coventry, Greene, Guilford, Oxford and Smithville]; Otsego County [Townships of: Butternuts, Laurens, Maryland, Milford, Morris, Oneonta, Otego, Unadilla and Worchester]; Tioga County: [Townships of Berkshire, Candor, Newark Valley, Nichols, Owego, Richford, Berkshire, Newark Valley and Owego. All territory from Smithboro, New York, in Tioga County, towards the City of Binghamton, New York All above within State of New York.

This rate shall not apply to projects where the owner lets multiple contracts for a single construction program unless the total of all contracts is less than \$5,000,000.

The employer is not required to fill all the above classifications if the project does not require the classification. If no work in a particular classification set forth above is being performed on the project, the employer is not required to fill that classification.

Nothing in this Agreement shall be construed as making the Association, Union or Employer liable for the payment of any wages, fringes, travel expenses, contributions, deductions or any other benefits except as specifically identified in this Agreement. The employers' liability shall be limited solely to the payments provided for herein, which when made shall fully discharge the employer from any further liability.
